## MERIT SCHOLARSHIPS

Saint Ignatius High School offers merit scholarships determined by Admissions Test (HSPT) scores. Students who score from 93-96 are awarded \$3,000 scholarships, and those students who score from 97-99 are awarded \$6,000 scholarships. A student must meet academic and disciplinary standards to be eligible for renewal annually. Prospective students are strongly encouraged to take an Admissions Test at Saint Ignatius High School on one of the dates offered in October and November. However, test scores from other schools may be accepted for scholarship determination. In order to be considered, these test scores must be submitted by **December 2, 2024**.

## NEED-BASED TUITION ASSISTANCE

All prospective students who would like to apply for tuition assistance for the 2025-26 school year must complete a **FACTS Grant & Aid application** to gather and analyze family financial information to assess a family's ability to pay tuition. In order to be eligible for need-based tuition assistance, **each student must also apply for one of the available ODEW scholarships** once forms are available in February 2025.

It is the policy of Saint Ignatius High School that both biological parents must file for financial assistance in order for financial aid to be granted to their student.

**All students in the State of Ohio are eligible** for either a Cleveland, EdChoice, EdChoice Expansion, or Jon Peterson\* scholarship through the Ohio Department of Education and Workforce. Applications will be made available in February 2025.

## DEADLINES & ADDITIONAL INFORMATION

FACTS Grant & Aid assessment application and all supporting documents must be completed no later than **November 15, 2024** if the prospective student/family wants to ensure that they will receive their financial assistance package before making their high school decision.

- Families who complete this process will receive an estimated tuition assistance award in writing by early January contingent upon completion of the ODEW scholarship application.
- Complete, accurate, and timely information is required. Applications submitted after the deadline and/or with incomplete or inaccurate information may result in reduction or denial of tuition assistance.
- **It is important to note that the deadline for prospective students (Class of 2029) is several months earlier than the deadline for returning students.** Families with both a returning student and prospective student must complete an application for their prospective student(s) by **November 15, 2024**, (based on their 2023 tax return) and complete an application for their returning student(s) by **May 1, 2025**, (based on their 2024 tax return).
- Students may receive more than one type of tuition assistance.
